REVISION OF PROVISIONAL ZONAL SENIORITY (ZONE-VI)

Sub:- Public Services – Commercial Taxes Department – Revision of Provisional zonal seniority of Zone-VI – Inclusion of Sri Putta Venkata Ramana, DCTO – Revision of seniority in the cadre of DCTOs for panel year 2008-09 – Issuance of Show Cause Notice - Regarding.

In the reference 1st cited, seniority list of DCTOs of Zone-VI for the panel year 2003-04 (part) to 2012-13 has been revised and finalized.

In the reference 2nd cited, the integrated seniority list of ACTOs of Hyderabad (Rural) Nodal Division and Secunderabad Nodal Division to the extent of DR ACTOs of 10/1999 batch (2004-05) was revised and finalized duly placing Sri Putta Venkata Ramana (Sl.No.12) above the name of Sri Suresh Vipparthi (Sl.No. 13).

Accordingly, in the reference 3rd cited, proposals were submitted to Government to allot Sri Putta Venkata Ramana, DCTO from Multi Zone-I to Multi Zone-II basing on the Hon'ble Supreme Court of India Orders in CA No.5099 of 2006, dtd. 18.02.2015 and subsequent orders dtd. 14.07.2021.

In the reference 4th cited, the Government have issued orders allotting Sri Putta Venkata Ramana, DCTO from Multi Zone-I to Multi Zone-II as his seniority in the cadre of ACTO was finalized in MZ-II above the name of Sri Suresh Vipparthi, ACTO who was junior to him. Accordingly, his seniority is proposed to be fixed in the cadre of DCTO, above the name of Sri Suresh Vipparthi (Sl.No.212) of DCTO seniority list of Zone-VI as in the reference 1st cited.

The list of effected candidates as per the existing zonal seniority of Zone-VI (Hyderabad (Rural) & Secunderabad Nodal Divisions) for the panel year 2008-09 & 2009-10 (to the extent of DR ACTOs of 10/1999 batch) for inclusion of Sri Putta Venkata Ramana, DCTO is enclosed as Annexure.

It is hereby issued to all the affected individuals and they are requested to file their written objections, if any, against the above proposed Revision of Seniority list of DCTOs on or before 06.10.2026 failing which, it will be construed that they have no objections to file on the proposed seniority and orders will be passed without further notice or time.

The above proposed revision of seniority list will be subject to the outcome of SLP/W.Ps/O.As/appeals pending if any, before the various Courts / Appellate Forums / Government etc.
